## **Associate of Science in Nursing (ASN)**

If an educational program offered by Mercy College is designed to meet or is advertised as meeting the educational requirements for a specific professional license or certification which is required for employment in the related profession, then Mercy must inform prospective and enrolled student of the following:

- 1. Each state in which the curriculum of the educational program meets the educational requirements for licensure or certification
- 2. Each state in which the curriculum of the educational program does not meet the educational requirements for licensure or certification
- 3. Each state in which the institution has not made a determination on whether the curriculum of the educational program meets the educational requirements for licensure or certification

The Mercy ASN program is designed to meet the Iowa Nurse Practice Act and is approved by the Iowa Board of Nursing (IBON), which is the nursing regulatory body (NRB) for Iowa. As an approved program, Mercy ASN graduates are eligible to take the National Council Licensure Examination for Registered Nurses (NCLEX).

The NCLEX is administered by the National Council of State Boards of Nursing (**NCSBN**). NCLEX registration is a two-step process: 1) register with a state NRB. 2) register with Pearson VUE to take the exam. NCSBN recommends registering with the NRB where you plan to live. The table below will inform you of whether the Mercy College nursing curriculum meets the curriculum requirements enforced by the NRB of other states.

If you register with IBON, upon successful completion of the NCLEX and satisfactory background check, IBON will issue you a license to practice in lowa, and you may use the title registered nurse or RN. Iowa is a member of the enhanced Nurse Licensure Compact (eNLC) administered by the Interstate Commission of Nurse Licensure Compact Administrators. The eNLC, allows RN's to have one multistate license, with the authority to practice in other eNLC member states As of 02/21/23, 39 states are eNLC members. https://www.ncsbn.org/compacts.page

In addition to the general disclosure identified above, if while taking courses at Mercy College a prospective student or enrolled student will be located in a state where the educational program does not meet or where the College has not made a determination on whether the curriculum meets the educational requirements, then Mercy College must provide the prospective student or enrolled student with personal, written notice.
